Specifically, I am interested in Section 14 Transitional and Final Provisions (The Government shall determine, within 12 months from the date of entry into force of this Act, the timetable and technical methods for the gradual digitalisation of acts included in the catalogue of services which are not yet provided as digital services or performed as digital acts and whose nature does not preclude it, for the period of the next 4 years. The notifiers of the agendas shall ensure the digitalisation of these acts. After this period, all such acts shall also be provided as digital services or be allowed to be performed as digital acts.)
